## A. Office of the Attorney General – Mary Ellen Clark

Ms. Clark advised that since the November 2010 meeting, the Legislature overrode Governor Crist's veto of House Bill 1565 with the directive that the provisions of that legislation take effect that day, November 17, 2010.

She stated that in addition to adding new requirements for rule-making, it puts the board in a position of backing up on its rules for things that already been completed.

Ms. Clark stated that the December Rules Report lists rules that she is aware of that are in play and includes the language that the board has already approved with the dates included.

She stated that Rules 61G7-5.001, 61G7-5.0033, and 61G7-5.005, F.A.C. are rules that the board have previously determined would negatively impact small business and would require a Statement of Estimated Regulatory Costs (SERC). She advised that those rules would need new SERCs before they can proceed.

Ms. Clark further stated that Mr. Morrison has been working with the department on how to comply with the new legislation.

Mr. Morrison stated he is working on the SERCs for the three rules and have completed the worksheets for them.

Ms. Clark advised that the board would have to review and approve the SERCs before anything else can happen to the rules.

Ms. Clark advised that the other two rules for which the language is known and the board has approved the amendments are Rule 61G7-10.0012 and Rule 61G7-10.002, F.A.C.

She stated before the board can proceed with these rules the board must consider the questions that must be addressed based on the new legislation.

Ms. Clark asked the following questions:

### Rule 61G7-10.0012, F.A.C.

1. Will the proposed rule amendments have an adverse impact on small business?

MOTION: Mr. Finkelstein moved that the proposed amendments to Rule 61G7-10.0012,

F.A.C. would not have an adverse impact on small business.

SECOND: Ms. Dockery seconded the motion and it passed unanimously.

2. Will the proposed rule amendments be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after implementation?
