SETTLEMENT STIPULATION – CHARLES ZENTER

Ms. White presented the facts regarding the Settlement Stipulation. She informed the board that this case had not been scheduled for a formal hearing at

The Settlement Stipulation would require that he only take the portion of the examination that he failed in March 2011, and then all scores would be combined together. Chair Fernandez stated that this would set a dangerous precedent. He added that the avenue for entry into this profession was through the exam room and not the courtroom or a threat of legal action.

In discussion, Ms. White informed the board that Captain Zenter had taken the examination four times.

Settlement Stipulation as presented.

SECOND: Commissioner Viso seconded the motion.

In discussion following the motion, Mr. Metzger and Captain Zenter addressed the board.

Following discussion, a vote was taken on the motion which passed unanimously.

Temporary Certificates
