After the application was amended by Mr. Miller to reflect the new amateur sanctioning organization's name, Dr. Williams asked for staff recommendation regarding Florida Combative sports application.

Ms. Hurtado reported that the staff recommendation was to approve the application for Florida Combative Sports as an amateur Mixed Martial Arts organization.

After discussion, the following motion was made.

MOTION: Mr. Martinez made a motion to approve the application for Florida Combative Sports as an amateur Kickboxing organization.

SECOND: Mr. Lopez seconded the motion and it passed unanimously.

REVIEW AND VOTE ON Jamie Levine- NOTICE OF DENIAL

Mr. Levine was sworn in by a Public Notary (Over the phone).

Mr. Milne asked Mr. Levine to confirm his receipt of a copy of the agenda with a copy of the police report related to his case, and Mr. Levine confirmed the receipt on both items.

Mr. Entin requested to withdraw this hearing.

After discussion, the following motion was made.

MOTION: Mr. Lopez made a motion to accept the withdrawal of this hearing.

SECOND: Dr. Kearney seconded the motion and it passed unanimously.

Mr. Milne advised the Commissioners to only use the provided information provided during this meeting when reviewing the recommended order.

Ms. White provided the commissioner with a new disk containing the information to be considered, Ms. White advised that the Commission will not oppose the recommended order.
