Dear Thomas,

The state of Kentucky will no longer offer reciprocity as outlined in our reciprocal agreement with your state. Kentucky will implement license recognition to issue licenses to candidates who have an active license in another state.

License recognition will require an applicant to have an active license in good standing in another state. The applicant will be required to complete a criminal background check with the FBI, obtain a letter of certification from each state in which they hold or have held a real estate license, and take the state law portion of the Kentucky exam.

The new legislation will be uniform, utilizing the same requirements for all out of state licensees making the process more efficient.

Please allow this to serve as notice of termination of our existing reciprocal agreement. A statement of release and termination has been attached for you to review, sign and return to our office. A postage paid envelope is enclosed for your convenience.

Thank you in advance for your attention to this matter. I look forward to working with you and your office in the future.


